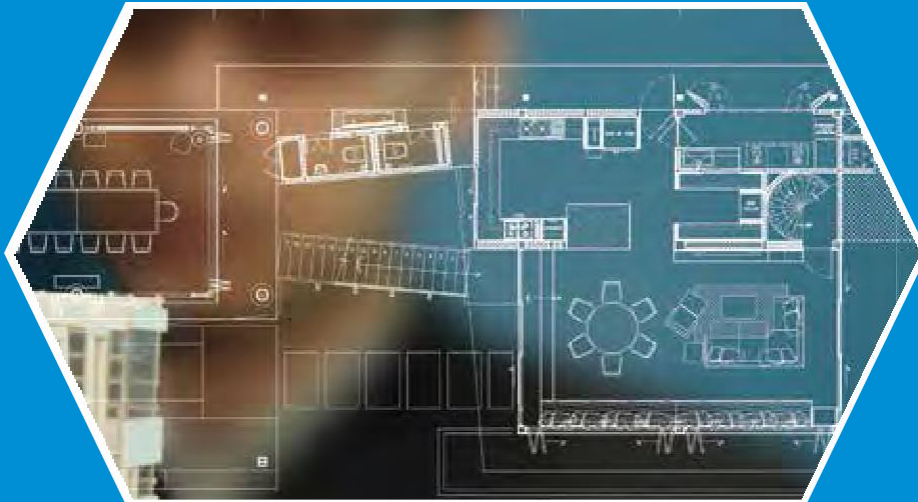

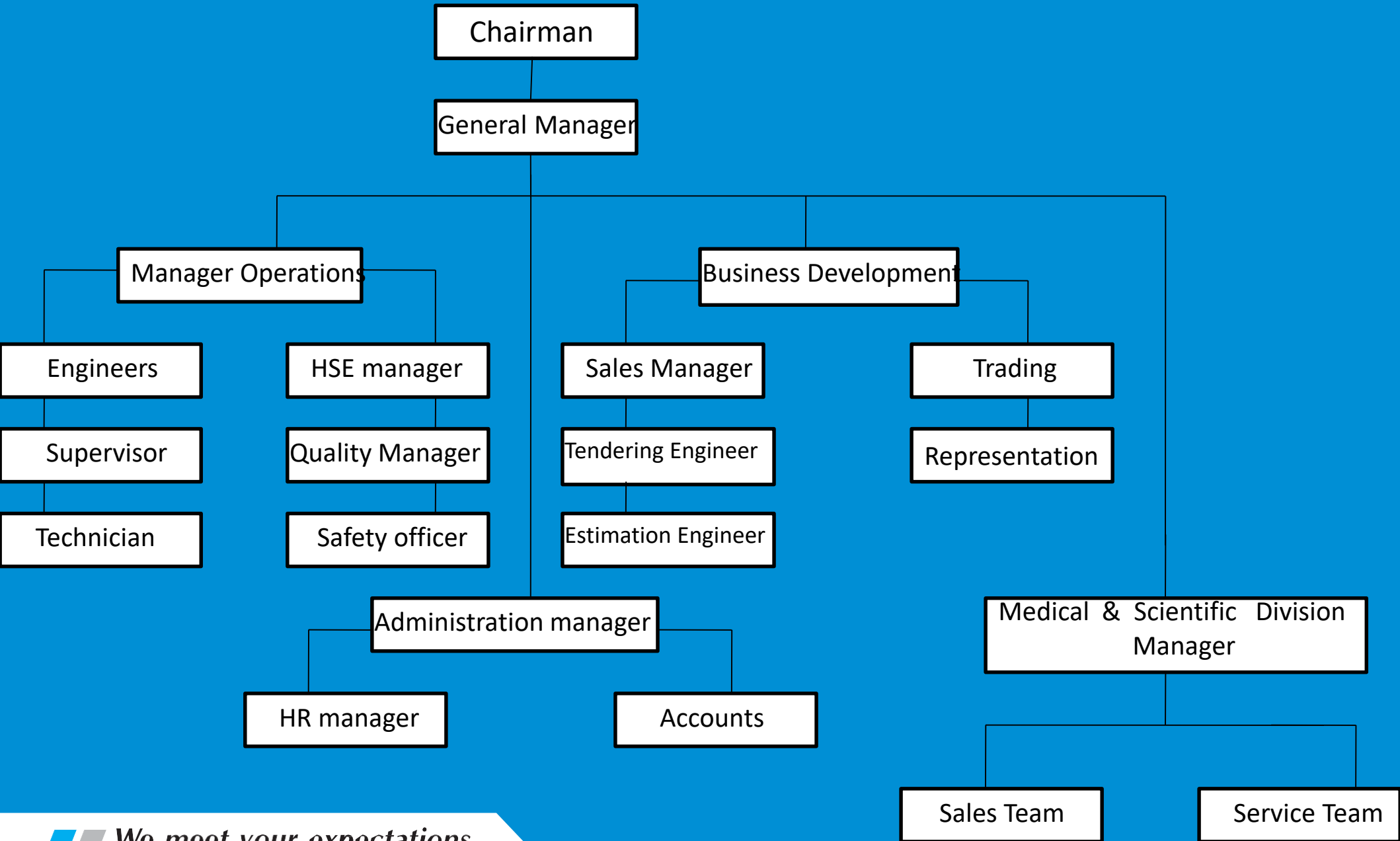

PAT testing is important to ensure a safe regime for employees and customers. In order to ensure compliance with accepted norms, all qualifying appliances will be tested as part of the regular maintenance routine.

Based on UK inspection regimes, inspection will involve a PAT tester examining the plug top of all appliances that need to be tested. The cord grip, polarity and termination tightness will also be examined and the appliances will need to be checked to ensure that no damage to the plug has occurred. Casing will be inspected to ensure that no cracks or visible damage is detected and any holes in the appliance cannot be larger than 6mm in radius.

There are different classes of equipment that are tested. These are categorised as follows:

- Class 1 includes equipment that is connected from the mains. The equipment in this category will have an earth connection from your mains and will likely have live parts that contain basic insulation.
- Class 2 includes equipment that does not have exposed metal work and contains at least two different layers of insulation.
- Class 3 includes all equipment that operates from power supplies less than 50v AC. These items will have basic insulation and will contain no metal work.
